#### **Tuition Payment Plan Terms and Conditions for Leadership University**

Below you will find our current tuition payment plan terms and conditions, please read carefully as these are the official terms and conditions enforced at the present time. The terms and conditions listed below surpasses any other written document you may have received prior to today's date. If you have any questions or comments about these terms, please do not hesitate to contact us.

Effective upon agreement between you (student or funding party) and **The Way Leadership University** (from hereafter referred to as '**TWLU**'), the following payment terms MUST be obeyed by all involved parties. In special cases, this agreement may be amended by other written arrangements but only if previously approved by **TWLU** staff.

#### **Payment Plan Options:**

**Certificate Program:** This is a reduced cost financial program only. All curriculum and student responsibilities will remain the same. Once the program and financial agreement are completed; you will receive a certificate of completion only. However, if you pay the additional cost (at time of signing) for the 20 Month Degree program we will then be able to reward a degree.

MEMBER: \$1000 NON-MEMBER: \$1000

For all member payment plans a \$50 non-refundable fee will be due upon application and, if approved, it will be deducted from your tuition balance. All members must provide membership I.D. Card or Membership certificate for fee to be applied.

Plan 1 and 3: The full tuition will be due PRIOR TO THE FIRST DAY OF SCHOOL.

MEMBER: \$2520 NON-MEMBER: \$3024

**Plan 2 and 4:** If you choose to pay by month then you are agreeing to a 20-month commitment for Auto-Pay of specified amount listed. Your payment is due every  $1^{st}/15^{th}/30^{th}$  of the month. Adjusted lump sum can be used if you want a lower monthly payment but you will need to pay the final tuition balance remaining in one lump sum to receive your degree.

2.	I agree that a formal withdrawal will need to submitted no later than 2 weeks from the start of school and an exit interview will need
	to be completed in order for a refund of any tuition fees is reviewed and approved (initial)
3.	I agree that any change to this Plan, this includes but is limited to: account change, postpone payment, or switching to another plan, needs to be requested two weeks prior to due date and if approved an administration fee of \$25 will need to be paid. If denied and resulted in late and/or returned payment, then penalties and late fees apply (initial)
4.	I agree to pay all my installments on time understanding that this means on or before the due date (initial)
5.	<i>Grace Period.</i> Will be honored three days after due date only if <i>promise to pay</i> is communicated to <b>TWLU</b> financial team via phone or email, by day four late charges apply (initial)
6.	If payment is returned for any reason, then I will pay the penalty and late fee, if applicable, in addition to the past due payment(initial)
7.	<b>Penalty and Late fee.</b> If my payment is returned for any reason, then ten percent of the returned amount will be added to the amount due. If I fail to pay the full due amount on the due date or by the terms of <i>grace period</i> , then I agree to pay a late fee of \$25 on each installment payment that is delinquent (initial)
8.	Tuition payments received are first applied against the oldest outstanding amounts (initial)
9.	<b>Notice.</b> A statement of your account status will be provided at the end of every quarter. I understand that failure to keep my account current and in good standing could affect my student status for the following term. (initial)
10.	Loss of eligibility for payment plan. If I fail to pay my installments on time on more than one occasion without communicating with TWLU financial team, then I risk my eligibility for a payment plan for the following quarter. (initial)
11.	Readmission withholding. If I have any outstanding balances then I will not be able to enroll for future terms until I fulfill my
